

DECISION

**On the approval for changing the trading registration of shares
of BV Land Joint Stock Company**

**GENERAL DIRECTOR
OF HANOI STOCK EXCHANGE**

- Pursuant to Decision No. 01/QD-HDTV dated June 30, 2021 of the Members' Council of Vietnam Securities Exchange on the establishment of Hanoi Stock Exchange;
- Pursuant to the Charter of Organization and Operation of Hanoi Stock Exchange issued together with Decision No. 08/QD-HDTV dated July 9, 2021 of the Members' Council of Vietnam Securities Exchange;
- Pursuant to Securities Law No. 54/2019/QH14, as amended and supplemented by Law No. 56/2024/QH15;
- Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of certain articles of the Securities Law, as amended and supplemented by Decree No. 245/2025/ND-CP;
- Pursuant to the Regulations on Registration and Management of Trading of Unlisted Securities issued together with Decision No. 23/QD-HDTV dated March 18, 2026 of the Members' Council of Vietnam Securities Exchange;
- Having reviewed the dossier for change of trading registration of BV Land Joint Stock Company;
- Upon proposal of the Director of the Listing Management Department.

DECIDES:

Article 1. To approve BV Land Joint Stock Company to change its share trading registration with the following details:

- Securities name: Shares of BV Land Joint Stock Company;
- Type of shares: Common shares;
- Ticker symbol: BVL;
- Par value: VND 10,000/share;
- Form of issuance: Shares issued to pay dividends;
- Number of additionally registered trading shares: 17,882,206 shares (Seventeen million eight hundred and eighty-two thousand two hundred and six shares);

- Value of additionally registered trading shares (at par value): VND 178,822,060,000 (One hundred and seventy-eight billion eight hundred and twenty-two million sixty thousand dong);
- Total number of registered trading shares: 107,293,493 shares (One hundred and seven million two hundred and ninety-three thousand four hundred and ninety-three shares);
- Total value of registered trading shares (at par value): VND 1,072,934,930,000 (One trillion seventy-two billion nine hundred and thirty-four million nine hundred and thirty thousand dong).

Article 2. BV Land Joint Stock Company is obliged to disclose information in accordance with current regulations and to comply with legal provisions on securities trading activities.

Article 3. This Decision takes effect from June 9, 2026. The Director of the Listing Management Department and BV Land Joint Stock Company are responsible for implementing this Decision.
